Explanation of Responses:

1. The reported securities are directly held by Frazer Holdings, LP ("Frazer Holdings"). The Estate of Nimrod T. Frazer (the "Frazer Estate") is the sole shareholder of Frazer Ventures, LLC, which serves as the general partner of Frazer Holdings. The Reporting Person, in his capacity as an executor of the Frazer Estate, may be deemed to beneficially own the reported securities. The Reporting Person disclaims beneficial ownership of the securities beneficially owned by the Frazer Estate except to the extent of the Reporting Person's pecuniary interest therein.

Remarks:

The Reporting Person is a member of a "group" for purposes of Section 13(d) of the Securities Exchange Act of 1934 (the "Group") that beneficially owns more than 10% of the Issuer's outstanding Ordinary Shares. The other members of the Group include Elk Evergreen Investments, LLC, Elk Cypress Investments, LLC, TSS Sub-Fund Holdco, LLC, Alan Waxman, Paula Mims (not in her individual capacity but solely as executor of the Estate of Nimrod T. Frazer), Frazer Holdings, LP, Frazer Ventures, LLC, the Estate of Nimrod T. Frazer, Anne Oros, Stuart Schlesinger, the John J. Oros 1998 Family Trust, the Hyman 2018 Family Trust, David G. Walsh, Steven D. Arnold, the Arnold 1997 Limited Partnership and SAS GP, L.L.C. (collectively, the "Other Group Members"). The Reporting Person disclaims beneficial ownership of the Ordinary Shares of the Issuer beneficially owned by the Other Group Members and this report shall not be deemed an admission that the Reporting Person is the beneficial owner of such Ordinary Shares for purposes of Section 16 or otherwise.
